Submission Instructions:

The form must be submitted to CMHA- NL by: **Tuesday, July 15, 2014**

Deadline for Art Submitted to the CMHA- NL: **Friday, August 15, 2014**

Mindsapes Art Exhibit on **Friday September 12, 2014- Wednesday September 17, 2014. Location to be announced at a later date**

Gala and Silent Auction: Thursday: **September 18, 2014**

Please note: If you piece(s) is selected to Mindsapes, you must place you own value on your work. The opening bid will then the value, + our framing cost divided by 2. The amount will be the opening bid of your art.

Common Questions:

1. Will this be a juried panel?

Yes, artists from Newfoundland and Labrador will jury your submission. From this jury, 25 pieces will be selected.

2. Does the work have to be created in 2014?

We would prefer that, and we would prefer that is not previously exhibited and exclusive to our show. It must be in keeping with the theme for this year, which is 'Celebrating the Journey.'

3. Do I have to send my artwork by July 15th?

No, you need to send your **intent to submit/submission form by July 15th**, the **dimensions** of your piece, the title, and tell us the type of media that you will be choosing to create your artwork. Then you have a month to get your piece in to us!

4. If I do not get selected for the exhibit, what will happen to my art?

You will be responsible for the cost of shipping your art to us, and having it returned to you.

Please note that your pieces have to be original, signed by you, the artist. Also this is an exclusive show. Please do not advertise your art on social media sites before the final decision of the 20-25 pieces by the jury. We will promote your work through the networks before the Gala on September 18, 2014. We would prefer if your art has not been previously exhibited, and is in keeping with our theme. CMHA- NL will be very careful with you entry. However, we will not be responsible or guarantee your artwork from any loss, damage, accident, theft, fire, humidity, or other means. It is the artist's responsibility to send the artwork to us on the date specified. CMHA is not responsible for the transporting of your piece to the jury, nor are we responsible for the cost associated with shipping to CMHA headquarters for the jury process. We also do not insure any pieces that are sent to us. Mindscapes and CMHA- NL encourage the artist to include the work under his/her insurance policy before submitting to CMHA- NL. Please ensure that your artwork has proper identification, and is signed on the front or back. If your piece(s) make it to the exhibit and gala, there will be a 50/50 split in the final auction sale bid, as in previous years.
